(Call for Applications) Global Fund for Women

The Global Fund for Women plays a leading role in advancing women's rights by making grants that support and strengthen women's groups around the world. The Global Fund for Women mobilizes and redistributes resources that enable women to develop creative solutions to local, regional, and transnational challenges. It brings grantees and donors together in an international network that promotes women's action for social change, equality, peace, and justice worldwide.

The Global Fund for Women envisions a just, compassionate and equitable world in which all people, regardless of their gender, class, age, ethnicity, race, religion, sexual orientation or physical ability may live free of poverty, violence, and all forms of discrimination. Each person and all peoples are guaranteed their fundamental human rights – civil, cultural, economic, political, and social. Women everywhere have a voice, have choices, and are able to realize their full potential within their societies. Proposals are accepted on a rolling basis and grants are awarded every 3 months.

(Call for Applications) The Global Fund For Children

The Global Fund for Children's mission is to advance the dignity of children and youth around the world. GFC pursues its mission by making small grants to innovative community-based organizations working with some of the world's most vulnerable children and youth, complemented by a dynamic media program that, through books, documentary photography, and film, highlights the issues affecting children and celebrates the global society in which we all live.

The needs of children and youth, though in many ways universal, are best responded to in ways that fit the particular situation on the ground. GFC therefore supports groups that are providing for the needs of children in a variety of ways—by giving scholarships to allow poor children to attend formal schools, by providing tutoring and after-school services to youth at risk of leaving formal schooling, or by establishing classroom environments on train platforms, in boats, on beaches, or at garbage dumps.

All potential grantee partners are first required to submit a preliminary letter of inquiry. Although GFC awards new grants only twice a year (in June and

December), interested organizations can submit a letter of inquiry at any time during the year. GFC uses the letter of inquiry to determine basic eligibility and fit with GFC's selection criteria. Please review our portfolios and eligibility criteria carefully before submitting a letter of inquiry.

#### (Resource) The Universal Declaration of Human Rights

On December 10, 1948 the General Assembly of the United Nations adopted and proclaimed the Universal Declaration of Human Rights the full text of which appears in the link provided. Following this historic act the Assembly called upon all Member countries to publicize the text of the Declaration and "to cause it to be disseminated, displayed, read and expounded principally in schools and other educational institutions, without distinction based on the political status of countries or territories." Here are a few of the main and important points from the Declaration:

1. Everyone has the right to life, liberty and security of person.
2. No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.
3. No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.
4. The family is the natural and fundamental group unit of society and is entitled to protection by society and the State.
5. Everyone has the right to freedom of thought, conscience and religion; this right includes freedom to change his religion or belief, and freedom, either alone or in community with others and in public or private, to manifest his religion or belief in teaching, practice, worship and observance.
6. Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers.
7. Everyone has the right to take part in the government of his country, directly or through freely chosen representatives.
8. Everyone has the right to work, to free choice of employment, to just and favorable conditions of work and to protection against unemployment. Everyone, without any discrimination, has the right to equal pay for equal work.
9. Everyone has the right to education. Education shall be free, at least in the elementary and fundamental stages. Elementary education shall be compulsory. Technical and professional education shall be made generally available and higher education shall be equally accessible to all on the basis of merit.

This Universal Declaration works to ensure that every human being is given equal rights and is treated justly. We at Firelight believe it is important to educate others on these basic rights in order to guarantee a better future for all individuals.

(Resource) Child to Child: Empowering Children as Active Citizens  
Child-to-Child (CtC) is an approach to health promotion and community development that is led by children. It is based on the belief that children can be actively involved in their communities and in solving community problems. CtC projects involve children in activities that interest, challenge and empower

them. In so doing, the approach "encourages and enables children to play an active and responsible role in the health and development of themselves, other children, their families and communities" Here are the two pillars that this approach is based on:

1. Popular education, or education for social change, is one of the key theoretical pillars underlying the CtC approach. First articulated by Paulo Friere in his literacy work with Brazilian peasants, popular education has been used in both poor and rich countries as a tool to raise people's awareness of how their personal experiences are linked with larger social problems.

2. Child participation is the second theoretical pillar of the CtC approach. In its broadest sense, child participation refers to children playing a meaningful role in the world around them. The principle of child participation is firmly rooted in the United Nations Convention on the Rights of the Child (CRC), which asserts that children have the right to participate as full members of society. In short, the CRC recognises that children are not merely "adults in training", but people who are able to form and express opinions, to participate in decision-making processes and to influence solutions.

Youth for Human Rights International (YHRI) is a nonprofit organization founded in 2001 by Dr. Mary Shuttleworth, an educator born and raised in apartheid South Africa, where she witnessed firsthand the devastating effects of discrimination and the lack of basic human rights.

The purpose of YHRI is to teach youth about human rights, specifically the United Nations Universal Declaration of Human Rights, and inspire them to become advocates for tolerance and peace. YHRI has now grown into a global movement, including hundreds of groups, clubs and chapters around the world.

Youth for Human Rights International teaches human rights education both in the classroom and in nontraditional educational settings. We aim to reach people from diverse backgrounds, with materials which often appeal across generations. By teaching human rights through all means—from conferences and workshops to hip-hop and dancing—this message has spread around the world.
